# Higher Education Emergency Relief Fund Report Financial Aid Grants to Students

**Triangle Tech (OPE ID: 02174400)** received grant funds awarded pursuant to Section 2003 of the American Rescue Plan Act of 2021 (ARP) (Pub. L. 117-2) (supplemental award or grant) by the U.S. Department of Education (Department), governed by section 2003 of the ARP and section 314 of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) (Pub. L. 116-260) and the terms and conditions of the Supplemental Agreement (ALN 84.425Q) ((a) (4) Program.)

The American Rescue Plan Act, 2021 (ARP) authorized the U.S. Department of Education ("ED") to allocate supplemental formula grant funds to proprietary postsecondary education institutions for the purpose of addressing student needs related to coronavirus.

The institution appreciates that Congress and the President have made these critical funds available for eligible students (including students exclusively enrolled in distance education), which may be used for any component of the student's cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.

# **ATTACHMENT A**

# Triangle Tech HEERF III Student Share Grant Policy and Procedure Award and Administration of HEERF III Funds Adopted September 20, 2021

### **Background**

In May 2021, the U.S. Department of Education ("ED") announced additional funding available to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic. This funding established the Higher Education Emergency Relief Fund III ("HEERF III") and was authorized by the American Rescue Plan Act of 2021 ("ARPA"), which was signed into law on March 11, 2021.

Under ARPA, HEERF III Student Share Grant funds may be used for any component of the student's cost of attendance, or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care), or child care.

The ARPA requires that institutions prioritize students with exceptional need and authorizes grants to students exclusively enrolled in distance education.

# **Purpose and Scope**

Triangle Tech is eligible to receive HEERF III Student Share Grant Funds. The following policy presents Triangle Tech's methodology for determining eligibility under ARPA, as well as the process and procedure for distributing and disbursing the HEERF III Student Share Grant Funds.

### **Policy**

Triangle Tech will make available 100% of HEERF III Student Share Grants to eligible students, consistent with the requirements of ARPA, and any subsequent guidance by ED.

Students enrolled in AST Degree and diploma programs may be eligible for the HEERF II Student Share Grant Funds.

Triangle Tech will not condition the disbursement of HEERF III Student Share Grant funds to students on continued or future enrollment at the school.

Triangle Tech will not use the HEERF III Student Share Grant funds to satisfy a student's outstanding account balance unless the School has obtained the student's written (or electronic) affirmative consent.

Triangle Tech will not require such consent as a condition of receipt of or eligibility for the HEERF III Student Share Grant funds.

# Eligibility

To be eligible to receive HEERF III Student Share Grant Funds a student must meet all eligibility criteria listed below ("Eligible Student"):

Students \*should have completed a Free Application for Federal Student Aid ("FASFA") for the 2021-2022 Financial Aid Year and have an official Expected Family Contribution ("EFC") on file with Triangle Tech's Financial Aid Department based on that FAFSA. Triangle Tech has concluded that the best way to determine a student's financial need is to verify that the student has completed a FAFSA, has received an official Student Aid Report ("SAR"), and has an official EFC on file for the 2021-2022 Financial Aid Year. Students received counseling by their Triangle Tech Financial Aid Advisor to complete the 2021-2022 FAFSA during their initial Financial Aid appointment. \*Students who have not filed a FAFSA will be considered in Group 4 for HEERF III funding.

\*According to the U.S. Department of Education's (ED's) Final Rule on 5/14/21, <u>any individual</u> who is or was enrolled at an eligible institution on or after March 13, 2020 is now eligible for HEERF I, HEERF II, and HEERF III student grants. According to the HEERF III FAQs and the Final Rule, this is true regardless of whether the student completed a FAFSA or is eligible for Title IV federal student aid. And, it applies retroactively to all students and for all three HEERF programs

Students must be enrolled as of June 29, 2021, for Summer 2021 semester funds, and must be enrolled as of October 18, 2021 for the Fall 2021 semester funds.

Students must submit a Triangle Tech HEERF III Student Share Grant application.

\*\*International, undocumented, and DACA students are eligible for HEERF III Student Share Grants.

\*\*According to the U.S. Department of Education's (ED's) Final Rule on 5/14/21, in addition to U.S. citizens and permanent residents, refugees, asylum seekers, Deferred Action for Childhood Arrivals (DACA) recipients, other DREAMers, and similar undocumented students are also eligible for student grants from all three HEERF programs. This also means that schools can award HEERF I, HEERF II, and HEERF III to students who are not enrolled in Title IV-eligible programs. This includes non-degree, non-credit, and continuing education students, students who are simultaneously enrolled in high school and college, students who have graduated or withdrawn, and so on.

# **HEERF III Student Share Eligible Expenses**

HEERF III Student Share Grant funds may be used for any component of the student's cost of attendance or emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care), or childcare, ("HEERF III Student Share Eligible Expenses").

As part of the HEERF III Student Share Grant Application process, students will be asked to certify they have eligible expenses as described above.

#### **HEERF III Student Share Grant Prioritization**

Consistent with ARPA, Triangle Tech will prioritize students with exceptional need in awarding HEERF III Student Share Grants to students.

For purposes of this policy, Triangle Tech has determined that Estimated Family Contribution (EFC) is an appropriate metric for measuring a student's need.

Triangle Tech will use the following EFC categories for purposes of prioritization:

EFC Category 1: EFC is less than or equal to \$5,846

EFC Category 2: EFC is more than \$5,846 but less than or equal to \$10,000

EFC Category 3: EFC is more than \$10,000 but less than or equal to \$40,000

EFC Category 4: EFC is more than \$40,000 OR Student did not file a FAFSA

Students in EFC Category 1 are considered by the Triangle Tech as "Students with Exceptional Need."

#### **Procedures**

# **Applying for a HEERF III Student Share Grant**

An Eligible Student may apply for a HEERF III Student Share Grant by completing an Application. Applications will hand-delivered to the student or e-mailed to the student's Triangle Tech e-mail address by the Financial Aid Advisor.

Once the Application is made available to students, Triangle Tech will accept Applications for an initial period of one week. (The "Priority Application Period"). **See Appendix A of this Policy for a Sample Application.** 

Completion of an Application does not guarantee that the Eligible Student will receive a HEERF III Student Share Grant award. Triangle Tech retains discretion to extend or make available subsequent application periods based on available HEERF III Student Share Grant funds.

# **Application Information**

As part of their Application, Eligible Students will indicate their interest in receiving HEERF III Student Share Grant funds and certify that they have incurred HEERF III Student Share Eligible Expenses.

Triangle Tech will not require the student to provide receipts or other expense documentation, but students are encouraged to retain documentation supporting the HEERF III Student Share Eligible Expenses.

# Review and Decision Regarding HEERF III Student Share Grant Award Amounts

Triangle Tech will accept Applications during the Priority Application Period and verify student eligibility in order to establish eligible applications ("Eligible Applications").

Based on the number of Eligible Applications received and available HEERF III Student Share Grant funds, Triangle Tech will determine a fixed dollar amount to be distributed to students within some or all of the EFC categories defined previously, with priority given to students in EFC Category 1.

The largest dollar amount (per student) will be awarded to students in EFC Category 1. The dollar amount (per student) awarded to EFC Categories, 2, 3 or 4 will be less than the amount (per student) awarded to Students with Exceptional Need.

Depending on available HEERF III Student Share Grant funds, and the number of Eligible Applications received, it is possible that certain EFC Categories may not be allocated any HEERF III Student Share Grant awards.

### **Disbursing HEERF III Student Share Grants**

Triangle Tech will make every effort to disburse the HEERF III Student Share Grants within two weeks of the close of the Priority Application Period.

Triangle Tech will notify students via their school email address of the amount of the HEERF III Student Share Grant awarded to them. As part of this notification, students receiving HEERF III Student Share Grant funds will complete a Disbursement Instruction form, and will have the option to instruct Triangle Tech to apply some or all of the HEERF III Student Share Grant funds as a payment towards any outstanding balance owed by the student to the school ("Student Account Balance"). **See Appendix B of this Policy for a Sample Disbursement Instruction.** Any Student Account Balance remaining after applying such payment remains the responsibility of the student. If applying this payment to the Student Account Balance results in a credit balance, the credit balance will be refunded to the student as part of the Business Office refund process.

Triangle Tech will disburse the HEERF III Student Share Grants to students accounts via the Campus Cafe Student Information Management System, but in no event shall the School apply any portion of such funds to pay down any balance owed by the student to the School without the student's written affirmative consent on the Disbursement Instruction form.

Students will receive the HEERF III Student Share Grant funds (or portion thereof) via a check made payable to the student.

# **Reporting and Tax Compliance**

Triangle Tech will comply with ED and IRS reporting requirements regarding funds awarded to students under ARPA.

Triangle Tech will issue the appropriate tax documents to students for these HEERF III Student Share Grants as required by the Internal Revenue Service.
